Objective)	Jamie appeared to be in a good mood, smiling throughout the day and greeting everyone quickly. Jamie tied his shoes on his own and prepared his snacks. Throughout the session, Jamie was not aggressive with the other kids, tolerating their turns in games 3 out of 5 times. When he asked for an extra snack, the therapist told him to wait for snack time and he threw a minor tantrum lasting for 10 minutes. The therapist used attention extinction by ignoring the tantrum and waiting until the rest of the children finished their snacks.
Α	Jamie's temper tantrums have decreased in frequency and intensity. The antecedent for the tantrums is not receiving attention or an item he wants. Jamie responds well to extinction mechanisms.

Ρ	Next session, introduce exercises to build cooperation and turn-taking activities. Otherwise, continue with a behavioral intervention plan for temper tantrums involving extinction mechanisms and instruct parents to do the same at home.

Ρ	Continue with the current treatment plan. Stay in step 2 of speech therapy until Casey reaches 90% success. Discuss the importance of being on time for sessions with parents and caregivers.

Α	Graduated guidance works on 100% of opportunities for teaching novel skill acquisition targets. Continue with Differential Reinforcement of Alternative Behavior without extinction to decrease escape-maintained behaviors.
